Join NAPFA now to fight for better access to public land in NSW

"Fights for fairer access to land in NSW and represents the interests of prospectors and fossickers"

The NSW and ACT Prospectors and Fossickers Association Inc (NAPFA) was formed in December 2012 to improve fossicking access to public land on behalf of all prospectors and fossickers in NSW and the ACT. Our goals are consistent with similar associations around the country and promote prospecting and fossicking for minerals (especially gold), gemstones and fossils; as well as for coins and relics.

NAPFA is a peak industry group in NSW and is well recognised nationally as a key player in the prospecting and fossicking industries for representing our needs to Government.

In November 1854 a flag, representing the Southern Cross, with white stars on a dark blue background, was flown at Bakery Hill. The diggers took the 'Oath of the Southern Cross'. They knelt, and with heads uncovered pointed to the banner and said:



"We swear by the Southern Cross to stand truly by each other and fight to defend our rights and liberties"

This is your opportunity to do just that. We seek to restore fair balance through better access and to improve regulations, and NAPFA has made a lot of progress to keep prospectors and fossickers access in the field.

FOSSICKING DISTRICTS - NAPFA's initiative to create more Fossicking Districts and ongoing lobbying of Local Governments has now added 27 more Fossicking Districts to NSW, and we haven't finished yet.

FOSSICKING in NSW PARKS - For the first time in history fossicking is now included in NSW Parks state policy. Since then, new management plans for the Nuggetty State Conservation Area (SCA) and the Cells SCA in the Cattan-Bimbang National Park were both amended to allow fossicking. The first in over 20 years.

LAND ACCESS: NAPFA have had many illegal restrictions removed, such as locked gates, and clarified access in several areas, including Tambaroora where others failed. Recently NAPFA were instrumental in lifting the Nundle Fossicking Ban and removing the requirement for Crown Land Permits to Fossick on "unmanaged" Crown Land.

HIGH BANKING PUMPS and POWERED EQUIPMENT – NAPFA continue to demonstrate the wrongful actions of the Dept. and NAPFA has made positive progress on resolving the "powered equipment" issue in the legislation and this is ongoing. Join us now to help win this battle !!!

As a specialised body, we present a strong, professional, and focussed presence on improving our rights as fossickers in NSW and make the necessary representations. The volunteer Committee works hard for your cause, and to do this we need the support of all prospectors and fossickers operating in NSW and the ACT, as many competing interests threaten to restrict our activities if we are not there to represent our members.

*** Membership categories

NAPFA has 3 types of Memberships: Children's, Individual and Family with options. NAPFA introduced a Children's Membership category in 2024 to allow children to become a member at a reduced cost.

Children's memberships

Previously children were included in Family Memberships, however, if parents or carers did not want to become a member, a child would have to pay the \$25 fee for an Individual Membership yet could not vote or stand for committee. The only benefit was to be included in the annual membership draw.

Now a child can join in one of 3 ways:

For a \$5 fee get a Children's Membership and get their own membership card and stickers;

For \$25 get a full Individual Membership; or

Be included in a \$40 Family Membership and an option for \$5 extra (\$45 total) for all children to get their own membership cards and stickers.
